The current version of the **Citrix ShareFile Sync for Windows** was tested for conformance with Section 508 of the Rehabilitation Act, specifically the U.S. Access Board's Technical Requirements. This product was tested as of **July 30, 2017**, and is only valid for the version and date it was tested.

Assistive technology products used as part of testing included Freedom Scientific JAWS 18.0, Freedom Scientific's MAGic® 14.0, Inspect, Microsoft Windows accessibility features, and keyboard-only control.
